**SUBJECT:** Chapter Dues Deadline

Please be advised that there were several legislative proposals that were passed at the 2019 Supreme Convention in Chicago requiring changes to the AHEPA By-Laws or Constitution. They are effective immediately.

In accordance with Article 3, Section A all members are now required to pay the annual chapter dues by no later than March 31 of the current dues year. This is a very important change. The section from the By-Laws is below.

Each Chapter shall have power to assess its membership regular **annual** dues at its discretion. Such **chapter** dues shall be payable in advance, **and no later than March 31 of the current dues year**. The members shall pay their dues to the Secretary, President, or Treasurer of the Chapter. The Chapter Secretary shall render to AHEPA Headquarters monthly-itemized statements of all monies collected for the Chapter. **This does not change the deadline provisions of Article 13, Section H. 1. of the Order of AHEPA Constitution.** 

Please include the following text below in your meeting notices ASAP.

As a reminder, according to the AHEPA By-Laws that were revised at the 2019 Supreme Convention dues for 2022 are due no later than March 31.

Therefore, we are advising all chapters that 2022 national dues need to be submitted to AHEPA Global Headquarters by **no later than March 31**, **2022**. This also includes the Sons of Pericles identified as dual members with AHEPA.
